In 2016-17, WCMCA, Inc. completed a real-time strategic planning process. Out of the sessions that included board and staff, a new mission, vision, identity statement, and core values were developed. To assess what the needs in the area were, WCMCA, Inc. involved the people that are served by the agency, partners, and staff. The following list are the needs that were identified by those groups:

A huge thank you to all volunteers for their gift of time. Thanks to board and staff, WCMCA, Inc. had another clean audit!

In June 2017, WCMCA, Inc. received the Outstanding Housing Partner Award from USDA Rural Development for our work in housing programs.





Weatherization and the Conservation Improvement Program (CIP) served 193 households with home repairs totaling \$1,070,631.

The Small Cities program rehabilitated 5 homes in the amount of \$63,185.87.



360 people received assistance from a MNSure navigator.

The WCMCA, Inc's Free Tax Preparation Program assisted 467 taxpayers in receiving \$600.297 in refunds to tax payers.





Ready Ride volunteers gave 425 rides, spending 1,155 hours driving older adults of for a total of more than 16,298 miles.



Statewide, 236 Family Assets for Independence in Minnesota participants purchased assets, which included 81.587 to purchase a home, start up a business or higher education.



PLUS Kids served 430 children and their parents with 2.185 hours of parenting time and safe exchanges.

Head Start served 50 children in homebased Early Head Start (ages prenatal-3), and 337 children in center-based Head Start preschool (ages 3-5).



93.6% of 4-year-old Head Start children met or exceeded expectations for kindergarten readiness.

100% of Head Start children completed their physical exams and 99% completed screening requirements.

#### Weatherization Success Story

Steven Koelln of Spruce Hill Township in Douglas County was especially grateful in December 2016, after his home was weatherized. His house received a complete energy overhaul—a new fuel oil furnace, attic air sealing and insulation, repaired duct work, a whole new house fan, and much more—at no cost to Koelln. "It was probably the best Christmas present I've ever received," said Koelln, a former farmer who is disabled and lives just south of Miltona, 15 miles northwest of Alexandria. "It was a real godsend".

A year after the work, he is realizing the great outcomes and is even more thankful. "It's made a huge difference in my home," said Koelln. "On cold days before I had the work done, I would sit in my living room and watch the curtains move. There was a steady draft in the house, and the walls and floors were cold. But now, I'm toasty warm in the winter, and the cool airs stays inside much better in the summer. My fuel oil bill has been cut in half, and my monthly electric bills have decreased 25% to 40% each month. I am tremendously grateful."
