This year, WCMCA celebrated 55 years serving the communities of west central Minnesota! We celebrated with an open house at a new home constructed by our Institutional Community Work Crew and enjoyed the attendance of our local elected officials.

A group of dedicated staff and volunteers traveled to the State Capitol for "Homeless Day on the Hill" to advocate for increased resources to assist those affected by the lack of affordable housing across Minnesota.

Heather Molesworth, Family and Community Services Director, completed the Certified Community Action Professional program and became WCMCA's second CCAP. CCAP is a rigorous program that educates professionals on the deep history of the Community Action Network and enhances credibility as a leader in the field. 

SUCCESS STORY

A client applied for rental assistance through WCMCA due to being injured at work, which resulted in a loss of housing.

She and her two kids became homeless and started staying with different family and friends. They applied for housing assistance through WCMCA and were placed on the Homework Starts with Home program.

With assistance from WCMCA staff, they were able to find affordable housing. Finding stable housing has allowed her child to attend school without missing any days; and her oldest child to graduate and join the National Guard.

Participating in the Homework Starts with Home program has allowed the family to take a breath, as they no longer have to worry about where they will stay, and focus on their future.

NEW PROGRAM AT WCMCA

WEST CENTRAL COMMUNITY LAND TRUST

WCMCA staff spent 2019 working with partners on a new form of homeownership called a Community Land Trust. WCMCA completed a feasibility study, and business plan for the Community Land Trust Program and will officially have its first two homes in the program in summer 2020.

We are excited to offer a part of the solution to the affordable housing shortage in west central Minnesota, and believe that homeownership can transform lives, neighborhoods and communities.

A Community Land Trust (CLT) is established to serve as a long-term steward of land and to protect long-term affordability and access to housing that is located on that land.

A Community Land Trust, providing affordable homeownership, buys or receives donated land and builds new homes and/ or acquires and rehabilitates exiting homes, and makes these homes available for sale to limited-income homebuyers, writing down the purchase price to an affordable level through the use of public and/or private subsidies. The CLT sells the home at an affordable price to an eligible, qualified homebuyer household but retains ownership of the land parcel on which the home sits, leasing the parcel to the homeowner through a 99-year, inheritable, renewable ground lease. The ground lease conveys to the homeowner an exclusive, durable, enforceable right to occupy and use the land, along with most of the rights and responsibilities available to traditional, fee simple homeowners. At the same time, the CLT ground lease details specific expectations and requirements regarding the homeowner's use and occupancy of the property while they own their home and limits the resale price of the home, should the homeowner ever decide to sell. In exchange for the opportunity to purchase a home they would not have otherwise been able to afford, CLT homeowners agree to limit the amount of equity they will keep through the sale of their home at resale, thereby allowing incoming limited-income homebuyer households the same opportunity and affordable price initially made available them.

SUCCESS STORY

The Energy Assistance Program recently assisted a family who lost their adult disabled son.

Since their son's birth, the mother stayed at home to care for him and was unable to work outside the home. Due to the wear on her body over the years from providing this care, she is now unable to work and is applying for disability for herself.

The husband and wife were struggling to live off the husband's income only and were unable to keep up with the bills. When they called WCMCA for help, they had a natural gas bill of \$1600.

When determined eligible, the family received a primary heat grant of \$305 and were able to utilize an additional \$1200 in crisis funds to cover nearly the entire bill.

When the mom heard of what we could provide to assist their family, she was speechless and flabbergasted. In tears, she expressed her gratefulness and was so relieved to have this weight lifted.
